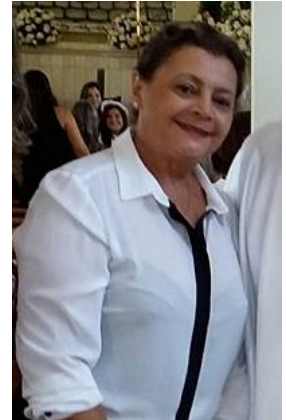

After the celebration of the 150th anniversary of the founding of the Congregation of the Franciscan Sisters of Allegany, Vilma was invited to

enter the Associate Program. Since then she has participated in Ministry to the Sick at Santa Casa de Misericórdia, worked with needy families being helped through the social services of the Franciscan Association for Education and Assistance - AFIA - and currently works in Vocational Ministry.

As an Associate she participates in all of the activities promoted by the Sisters, such as Assemblies, various celebrations and, most memorably, the celebration of

the founding of the Associate Program in Allegany.

Retreat Day at South Jersey

The South Jersey Associates designate one meeting day during the fall/advent season for a retreat. This year our November meeting was held at St. Thomas Aquinas Church, an annex of St. Francis of Assisi Parish in Beach Haven, New Jersey. The presenter was Fr. Michael Sullivan, an Augustinian friar whose ministry is conducting parish missions and retreat days. Joining our associate group for the day were the local Contemplative Living Group and the Secular Franciscans, for a total of 30 in attendance.

Father's focus was to examine our own life journeys. Throughout the morning he referenced the fruits of a positive attitude in dealing with life's challenges. He posed introspective questions to consider such as: "Are we children of yesteryear? Do we ruminate about past hurts, letting them harden our hearts into a lack of forgiveness?" "Are we perhaps children of Tomorrowland? Is the future what we focus on by worrying

about what will happen tomorrow?" "What do we worry about? Health? Money? Children?"

Father also led the group to think about the many blessings in our lives. Following the question "What blessing do you take for granted?" several people volunteered examples from their own life experiences. An awareness and gratitude for the good things that abound in our lives is one road to peace.

Father then asked us to fill in the blank, "Life is ____". He continued by providing his thoughts that life is basically unfair. What is important is not what happens to us, but rather how we respond. Jesus preached love, peace, forgiveness and healing. Each person is the result of relationships and summation of our memories. If we have suffered because of either of these, then we must pray for healing. Father then asked everyone to close their eyes as he offered a "Prayer for Healing of Memories".

After lunch and conversation, we shared another hour of examining the mystery of life, the crosses we bear, references to our Blessed Mother Mary who accepted the mystery of her role as the mother of Jesus and ideas about achieving peace within our lives. The very uplifting day ended at 2 pm.

Historic Blessing

Tampa Bay Associate Linda Dees (right) holds a Savings Card filled with 10-cent stamps. She found the personal treasure when her father, a lifelong stamp collector, was going through his collection. "The savings account belonged to my Mom, who passed away over 20 years ago. I had no idea she owned a United States

Savings System account," said Linda, who has been a postal employee for 28 years.

An Act of Congress on June 25, 1910, established the Postal Savings System in designated Post Offices, effective January 1, 1911. The Savings Stamps were available in denominations of 10-cents, 25-cents, 50-cents, \$1 and \$5.

After the war, banks raised their interest rates and began

offering the same governmental guarantee. US Savings Bonds gave higher interest rates, causing deposits in the Postal Savings System to drastically decline in 1964. The savings ended on July 1, 1967.

Linda, who was a Franciscan Sister of Allegany for seven years, said the unexpected discovery of her mother's United States Postal Savings System account was "like a

blessing from above" and has sentimental value.

Besides being an Associate of the Franciscan Sister of Allegany, Marlene Eaton is a volunteer for the McKean Potter County Pennsylvania Chapter of the Red Cross. She recently went on a deployment to North Carolina following the damage in many areas due to Hurricane Matthew. She flew into Fayetteville, NC, then traveled to Ft. Bragg to receive a badge to be used for entering the facility. After finally arriving at the Red Cross office, she was assigned to help in Lumberton, NC.

Reaching Lumberton, the Red Cross office was set up at Hyde Park Baptist Church where the North Carolina Baptist Men Mission assisted the

Red Cross in helping those in devastated areas. The Baptist women did the cooking for the Red Cross. Thousands of meals were taken to areas where people needed them. Electricity was out in these areas for many days and water had to be brought in also. Many streets had debris that had been taken out of the homes, along with walls because of growing mold. America Core and college students were also there for a week.

The faith of the people they helped there was great. They were very appreciative of what the Red Cross and others had done. Many said "God bless you for what you are doing!" This will be an experience that she won't forget.

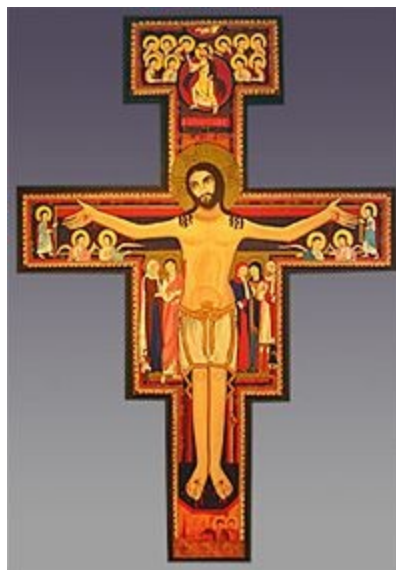
